# **Serious Game Projects**

**EarthQuest** (1999 to present). Game for teams of youth and young adults exploring climate change, sustainability, the local environment and civics. Uses hybrid table-top scenario and simulation methods with storytelling, group role-playing, and a digital multimedia story map for mobile devices. Players take on the role of their future descendent and explore a plausible near-future world, where they learn actual skills to address real-world issues from legacy environmental pollution, climate-induced events, socio-political dilemmas, and the transition to sustainability and resilience. Players also earn points in the game for doing real-life outdoor environmental service and adopting sustainability behaviors at home.
